All pools less than 48" inches in height from grade shall be completely enclosed by a fence or barrier not less than four (4') feet in height for protection of the general public. The gates shall swing away from the pool area and have a self-closing and self-locking device with latches placed 54" above grade on the outside of the gate to comply with locally adopted code; or may be equipped with an approved safety cover.

Where an above ground pool structure is used as a barrier or where the barrier is mounted on the top of the pool structure and where the means of access is a ladder or steps, the ladder or steps shall be capable of being secured, locked or removed to prevent access or the ladder or steps shall be surrounded by a barrier that meets the requirements of the code. All doors with direct access to the pool shall be equipped with an alarm which produces an audible warning when the door or its screen or window, is opened.

I understand that necessary safety precautions must be met during construction and the pool enclosure protection requirements of the 2015 Michigan Residential Code must be completed prior to filling the pool with water.

PLACEMENT REQUIREMENTS AND INFORMATION

1. **MISS DIGG (1-800-482-7171) Staking must be complete BEFORE pool placement inspection.**
2. Pool and equipment must be a minimum 5' from any "public utility" easement (1' if a storm sewer easement only).
3. Pool and equipment must be a minimum of 10' horizontally from any overhead lines.
4. Pool and equipment must be a minimum of 10' from house and 6' from property lines and/or accessory structure. Corner lots must follow ordinance setback.
5. **Site plan drawn to scale, showing location of pool with accurate dimensions and all existing structures and easements. Yard must be marked according to drawing and accessible for inspection (gates unlocked and dogs secured for all inspections).**
